# Thunder Road Time Trial

**Registration:** Avoid the Sunday morning wait in line with day-before registration on **Saturday May 29, 2010 from 1-4 p.m. at Sabino Cycles, 7045 E. Tanque Verde Road, Tucson, Ariz. 885-3666.**

**Race day registration is Sunday May 30 from 5:30-6:30 a.m. at the race site.**

For U.S.A.C. licensed riders only -- One-day and annual licenses will be available for purchase.

Race-day registration and start/finish at Sahuarita Road and Alvernon Way, 2.5 miles east of South Nogales Highway, just east of Sahuarita Park. Registration opens at 5:30 a.m. and closes at 6:30 a.m. The start list will be posted by 6:45 a.m. with the **FIRST RIDER OFF AT 7 A.M.**

**DON'T MISS YOUR START TIME PLEASE! THE CLOCK STARTS YOUR TIME WHETHER YOU ARE THERE OR NOT!**

**COURSE:** The course is out-and-back, heading 8 miles up a slight climb to the turn near Corona de Tucson at Houghton Road. The return leg is a fast downhill to the finish. This is a fast course but it is sometimes windy.  
**DISTANCE:** Total distance is 16 miles.

**NOTE:** After crossing the finish line please **carefully** turn left off Sahuarita Road onto Alvernon Way when warming down. Be aware of automobile traffic. The course is **NOT** closed to traffic, so be careful at all times. Please be extra careful and aware of cars at the start, turn and finish areas.

**ENTRY FEE IS \$20 PER RIDER PER CATEGORY, EXCEPT JUNIORS WHO PAY ONLY \$3 TO COVER U.S.C.F. INSURANCE.**
